This amending agreement dated August 23, 2022 between Alexis Park All Suite Resort & Conference Center ("Resort") and Southern Nevada Anthropomorphic Events ("Meeting Group") amends the original fully-executed agreement dated August 9, 2022.

On this date, August 23, 2022 Alexis Park All Suite Resort and Southern Nevada Anthropomorphic Events enter into this Addendum for the purpose of:

Meeting Event Space: Revising the original contracted meeting event space to include Hospitality Suite 2009 for dates April 14-16, 2023 and Rooftop Terrace April 14-15, 2023.

**Staff/VIP Hotel Suite Room Block:** Revising the original contracted suite accommodations to include three (3) Majestic King Suites and one (1) Regal 2-story 2-bedroom suite.

Deposit and Payment: Revising the original contracted deposit and payment schedule.

### **DEPOSIT AND PAYMENT:**

The Meeting Group agrees to pay and the Resort is anticipating revenue of \$37,800.00 (excluding taxes and gratuities) for this event. This amount is an estimate of the charges for the guest rooms and function space associated with the terms of this contract. A non-refundable deposit payment in the amount of \$1,000.00 must be accompanied with the signed contract to make the group definite. The balance of the Group's charges shall be paid as follows:

2<sup>nd</sup> Deposit on or before September 12, 2022 in the amount of \$3,000.00

3<sup>rd</sup> Deposit on or before October 10, 2022 in the amount of \$3,000.00

4th Deposit on or before December 12, 2022 in the amount of \$3,000.00

Any Remaining Balance will be due 72 hours prior to the first day of your event if paid by cash or Credit Card. If you prefer to pay the balance by check, cashier's check, or money order payment is due 7 days prior to the first day of your event.

If credit card is used for payments, the card will be charged for the amount listed above immediately to execute this contract. If a Master Account (Direct Bill) is to be applied for, the initial deposit much accompany this contract. With approval, the remaining deposits must be paid per above schedule. The basic fee must be paid in full prior to the departure of this group form the hotel.

### **APPLICATION OF NEVADA LAW:**

This Agreement, and the application or interpretation hereof, shall be governed exclusively by its terms and by the substantive and procedural laws of the State of Nevada. The parties hereto consent to the exclusive jurisdiction and venue of the federal and state courts in Las Vegas, Nevada, with respect to any controversy arising out of this Agreement or the transactions contemplated hereby.

"By signing this Agreement, you agree to pay Alexis Park Resort's attorney's fees and costs, in the event that you breach your obligations under this Agreement and/or cancel the Agreement and Alexis Park Resort retains an attorney to enforce the Agreement and/or collect money due under the Contract."

All other terms of the original contract, on file, dated August 9, 2022 remain as previously agreed. If you are in agreement with the contents of this proposal, please sign on the space indicated and return to the Resort, by September 2, 2022. Space is confirmed on a definite basis only after receipt of this agreement signed by Southern Nevada Anthropomorphic Events and countersigned by the Resort.

The Alexis Park Resort's current Catering / Convention Services Policies are attached and as such are incorporated into this agreement; subsequently, by signature of the agreement will be binding by both parties. This constitutes the entire agreement between the parties and it may not be amended or changed unless done so in writing and signed by the Resort and the Meeting Group. Facsimile signatures shall be sufficient unless a third party requires originals.
