



# Parental Consent Form

## Las Vegas Fur Con 2023

Adopted by the Board of Directors on October 18th, 2022

Las Vegas Fur Con (“LVFC” or “the convention”) is an annual convention organized by Southern Nevada Anthropomorphic Events, a nonprofit corporation organized under the laws of the State of Nevada. **Be aware that your child may be exposed to “PG-13” behavior while attending the convention.** The convention is an unsupervised environment intended for mature adults and is not responsible for the actions of attendees. **Convention staff cannot and will not supervise your child**, and will not act as a temporary parent for your child. You and your child will be ejected from the convention if your child is left unsupervised.

If your child will be 16 or 17 years of age during the convention, your child may be left unsupervised. However, they will still be required to follow all other guidelines marked in this document. **THIS FORM MUST BE SIGNED AND NOTARIZED IF YOU WILL NOT BE PRESENT AND YOUR CHILD WILL BE 16 TO 17 YEARS OF AGE DURING THE CONVENTION.** Please note that you may be required to sign and submit an additional liability form before or at the convention.

All attendees age 15 and under, and any attendees age 16 or 17 without a notarized Parental Consent Form, must be accompanied by their parent or guardian at all times while attending Las Vegas Fur Con. Children will not be permitted to attend with any adult other than their parent or legal guardian. The parent or guardian must pay for registration and receive an attendee badge. However, registration is free for attendees 15 and under.

You are also responsible for ensuring that your child obeys our Attendee Code of Conduct (<https://lasvegasfurcon.org/attend/code-of-conduct/>) as well as the LVFC Minor Code of Conduct, whether or not you are present. The LVFC Minor Code of Conduct is outlined on the next page. Code of Conduct violations by either you or your child will result in revocation of both your attendee badges and expulsion from the Convention Center. Please note that [Clark County Code 12.12.030](#) restricts minors from public streets and public places from 12am - 5am on Friday and Saturday, 10pm - 5am on all other days. It also restricts minors on the Strip from 9pm - 5am on Friday and Saturday. Please ensure your child stays in compliance with this local curfew.

## LVFC Minor Code of Conduct

1. Minors and their parent(s) or guardian(s) must wear their attendee badges at all times while in the Convention Center. Minors will be given a specially-marked badge. Any minor or parent/guardian caught not using the appropriate badge will be asked to leave the space until both are worn and clearly visible.
2. Minors may not, under any circumstance, enter areas marked “18+” or “Adults only,” even if allowed by a parent or guardian. Such areas include but are not limited to: bars, kink safe spaces, adult panels and dances, and adult hangout spaces.
  - a. Minors may not, under any circumstance, purchase any merchandise marked as “18+” or “Adults only.” Minors in possession of such merchandise may have said merchandise confiscated by convention staff, without refund.
3. Minors may not be left unattended on the Alexis Park property at any time. The result of this occurrence will be marked as a warning and the minor **will have to stay with security until the parent takes them.** Minors are considered left unattended if they are not with a parent or guardian at the convention for more than thirty (30) minutes. Failure to receive the minor in a timely manner will result in potential expulsion of both attendees from the convention.
  - a. Minors ages 16 or 17 with a notarized Parental Consent Form are not subject to this rule
