This contract agreement is entered into between Southern Nevada Anthropomorphic Events (henceforth "SNAE"), a Nevada NRS 82 nonprofit corporation, and [REDACTED] LLC (henceforth "[REDACTED]"), a Nevada domestic limited liability corporation.

NON-DISCLOSURE:

SNAE agrees to not publicly disclose the involvement of [REDACTED] in its merchandise and other operations. Only members and officers of SNAE's board of directors shall be aware of this partnership.

Should an interested third party approach SNAE to discuss its product sourcing, SNAE shall give the third party's contact information to a [REDACTED] representative, with [REDACTED] deciding whether or not to contact the third party.

PRODUCT DESIGN:

SNAE shall have full discretion which artists to use for designing its product line, including but not limited to: shirts, plushes, pins, and prints.

SNAE shall have the right to use [REDACTED]-affiliated artists, but must go through [REDACTED] to do so.

PRODUCT MANUFACTURING:

[REDACTED] shall have first refusal on all manufacturing sourcing, serving as SNAE's official merchandise broker.

[REDACTED] agrees to waive fees such as brokerage, prototyping, and testing fees for most products such as plushes. An addendum will discuss any exceptions.

FULFILLMENT OF PRODUCT:

SNAE has full discretion on how to market and fulfill orders for its merchandise line.

SNAE has the option to lease fulfillment, in whole or in part, to [REDACTED] in exchange for a commission per item sold; this commission rate shall be included as an addendum.

SNAE agrees to retain customer data for any orders for which fulfillment is leased to [REDACTED].

COMPENSATION:

In exchange for its services, for the duration of this agreement, [REDACTED] shall have a guaranteed, complementary vendor booth at all SNAE events. All [REDACTED] staff shall be entitled to complementary attendance at these events.

AGREEMENT TERM LENGTH:

This agreement shall last four (4) years from signing unless extended or cancelled with the consent of both parties.

UNILATERAL TERMINATION:

[REDACTED] shall have the right to unilaterally terminate this agreement if it judges that continued partnership with SNAE may hurt its brand, finances and/or reputation.

EFFECTIVE DATE:

This agreement shall be effective from the date of signing by both parties' representatives.
